2. The promotion is subject to the outcome of any further orders that may be passed by the Hon'ble Supreme Court of India in Jarnail Singh batch of cases in SLC(C) No. 30621 of 2011.

3. The promotion of officers at Sl. No. 61, 64, 65, 66, 67, 68, 69 and 70 will be effective from the date on which they complete the mandatory training.

4. All the officers are directed to assume charge within 10 days from the date of issuance of this order or the date of completion of mandatory training, as the case may be. If any officer does not want to accept the promotion, she/he may make a written request to this office giving reason for refusal of promotion. In case, the officer in the **Table- 'A'** above, fails to join by 07.01.2024 (other than officers who have not completed Mandatory training), it shall be assumed that the officer has refused to accept promotion.

5. The Principal Commissioner/Principal ADG/Commissioner/ADG and all other supervising Authorities shall ensure that if any of the officers whose name has figured in Table A above is under suspension or facing any charge sheet or prosecution, she/he should not be allowed to assume the charge of the post of Superintendent and this fact should be reported to the CCA, CGST & CX, Kolkata Zone immediately. Further, if any of the officer figuring in the Table – A has taken VRS or has resigned or has expired, this order would not be applicable to him/her and the supervising authority shall report the facts relating thereto to the CCA, CGST & CX, Kolkata Zone immediately.

6. All the concerned field formations are requested to forward compliance report by 10.01.2024 in respect of the officers mentioned in the Table- 'A' above.

7. The above named officers will be entitled to pay-fixations under FR 22(I) (a) (1) and will exercise option within one month from the date of assumption of charge.


