2. Since, no officer is allowed to hold sensitive charges for more than two years at a stretch, respective Administrative/Controlling Authorities of the concerned Commissionerate/Division shall verify this criterion properly (on the basis of office records) while making such internal posting. Further, Vigilance Clearance, Integrity Certificate, Agreed Lists and Officers of Doubtful Integrity List may be checked before giving sensitive charges.

3. The Posting of Shri Chandan Mondal (D.O.B:- 18-01-1973) at Haldia Non-CCA at Sl. No. 17 of Establishment Order No: CCA/53/2025 dated: 17-06-2025 stand cancelled. Date of Birth of Shri Chandan Mondal at Sl. No. 13 may be read as 18-01-1973 instead of 18-01-1979.

4. Shri Sitangshu Biswas (D.O.B: - 27-02-1977) UOT from Haldia N-CCA (A&N) to Kolkata North Commissionerate at Sl. No. 134 of Establishment Order No: CCA/53/2025 dated: 17-06-2025 is to be relieved on 30-09-2025 on the basis of his representation.

5. The officers against whose name Non-Sensitive posting is marked in executive Commissionerates shall not be posted in any sensitive formations except Ranges.

6. Respective Administrative/Controlling Authorities of the concerned Commissionerates/Divisions are hereby requested to relieve the Officers, who are under Order of transfer to CC (P) WB, only after issuance of their Vigilance Clearance and Integrity Certificate.

7. All Officers who are proposed for transfer shall prepare charge handing-over note within 05 days of issuance of this Order and the same shall be handed over to his/her Supervising Officer at the time of relieving.

8. All the above mentioned officers may be relieved from their present places of posting on or before 07-07-2025 with the direction to join their new places of posting. No representations whatsoever shall be entertained before they join their new place of posting.

9. As a regular practice, all the Commissioners are requested to issue the rotation orders in respect of the officers posted in their Commissionerates as per the norms of rotation prescribed in the Transfer & Posting Policy published on 02-05-2025.

10. Minor error / omission in the spelling of name or incorrect date of birth of any of the above officer(s), if any, should be avoided and/ or corrected by the relieving authority in the relieving order taking into consideration the correspondence data of the officers available at their end.
