This is to notify that in terms of Clause 6 & 7 of the Bye-laws of the AIASCT, Kolkata Unit, the Executive Committee (EC) of the Kolkata unit of AIACEGEO in its meeting held on 8<sup>th</sup> December, 2025 have decided to conduct election of the next Executive Committee and to hold the XII<sup>th</sup> Convention of this unit in the following mode and schedule:

### 1. Mode:

(a) The Executive Committee shall be formed by seventeen (17) members including two (2) each from South Bengal (resident of South Bengal) and North Bengal Region (resident of North Bengal) directly elected by all the members of the Association through secret ballot.

(b) For the purpose of above South Bengal shall represent the districts of Bankura, Birbhum, Purulia,

Bardhaman and Murshidabad and North Bengal shall represent the State of Sikkim and districts of Darjeeling, Jalpaiguri, Coochbehar, District of Alipurduar and Kalimpong North and South Dinajpur and Malda;

(c) The Executive Committee shall elect the Office Bearers by simple majority of vote of all the seventeen (17) members. The following shall constitute the Office Bearers:

(i) President; (ii) Vice President; (iii) Secretary; (iv) Assistant Secretary; (v) Assistant Secretary (South Bengal - posted at Bolpur); (vi) Assistant Secretary (North Bengal posted at Siliguri); (vii) Treasurer.

(h) Date of XVI<sup>th</sup> Convention: **27.02.2026**
