2. **Officers who are yet to complete their tenure of 4/2 years in a particular Commissionerate as Inspector stipulated in transfer and posting policy of Superintendent / Inspector, 2025, are retained in their present place of posting as far as possible subject to vacancy and representations. These officers will be transferred out from their respective Commissionerates on completion of 4/2 years tenure (Inspector + Superintendent) depending on sensitive/ Non sensitive formation.**
3. **In light of limited vacancies in CCP, the officers who have joined CC(P), WB after 01.04.2023 are retained in CC(P), WB and they will be transferred out from CC(P), WB on completion of their 04 years tenure (Inspector + Superintendent).**
4. The tenure of posting of the officers shall be counted from the date of joining at a new place of posting. Those retained in existing formations, the tenure shall be counted from date of original joining in the formation.
5. The officers mentioned above should as far as possible be relieved from respective Commissionerates on or before 10.04.2026. **However before relieving it may please be ensured that the officers have not been selected for any election related duty and the provisions of MCC are not violated.**
6. Concerned Commissionerates are requested to forward consolidated/ compliance report (regarding relieving and joining in respect of each officer) to the O/o the Chief Commissioner, CGST & CX, Kolkata Zone by **14.04.2026** in the format as under-
