2. Respective Administrative/ Controlling Authorities of the concerned Commissionerate/ Division shall ensure that officers are posted to sensitive or non-sensitive position looking into the previous postings of officer (on the basis of office records) while making such internal posting. Further, Vigilance Clearance, Integrity Certificate, Agreed lists and Officers of Doubtful Integrity List may be checked before giving sensitive charges.

3. **In Non-CCA formations, the jurisdictional controlling officers are requested to relieve officers under their control only after being satisfied that the concerned officers have duly served/ completed the Non-CCA tenure of 1 & ½ year period (One (01) year for Andaman & Nicobar Division under Haldia Commissionerate and Darjeeling Hills and State of Sikkim under Siliguri GST Commissionerate). It may be noted that period of earned leaves taken in excess of 30 days, if any, has to be served by the concerned**

officers in Non-CCA posting in addition to 1 & ½ year period (One (01) year for Andaman & Nicobar Division under Haldia Commissionerate and Darjeeling Hills and State of Sikkim under Siliguri GST Commissionerate). The officer should not be relieved before that. The Non-CCA postings of the officers will be counted from the date of joining at new place of posting and not from the date of the order.

4. Officer featured in Sl. No. 181 shall complete his less-HRA tenure after three (03) years, i.e. completion of his ward's Board Examination.
5. The officers in Executive Commissionerates against whose name Non-Sensitive posting is marked shall not be posted in any sensitive formations except ranges till they do not complete their Non-CCA tenure.
6. Respective Administrative/Controlling Authorities of the concerned Commissionerate/ Divisions are hereby requested to relieve the officers who are under order of transfer to CC(P), WB after issuance of their Vigilance Clearance and Integrity Certificate.
7. All officers who are proposed for transfer shall prepare charge handing-over note within five (5) days of issuance of this order and the same shall be handed over to his/her Supervising Officer at the time of relieving.
8. All the above mentioned officers may be relieved from their present places of posting on or before 15.05.2026 with the direction to join their new places of posting. No representations whatsoever shall be entertained before they join their new places of posting.
9. As a regular practice, all the Commissioners are requested to issue the rotation orders in respect of the officers posted in their Commissionerates as per the

norms of rotation prescribed in the Transfer and Posting policy published on 02-05-2025.

10. Minor error/ omission in the spelling of name or incorrect date of birth of any of the above officer(s), if any, should be avoided and/or corrected by the relieving authority in the relieving order taking into consideration of the corresponding data of the officers available at their end and communicated to the Cadre Controlling Authority, Pr. CCO alongwith the consolidated report.
11. Concerned Commissionerates are requested to forward consolidated/ compliance report (regarding relieving and joining in respect of each officer) to the O/o the Chief Commissioner, CGST & CX, Kolkata Zone by 29.05.2026 in the format as under-
