The following clarifications have been made in view of the above said Order :-

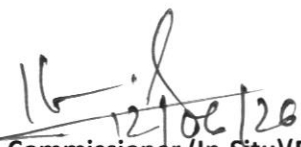

This issues with the approval of the competent authority, CGST & CX Bolpur Commissionerate.

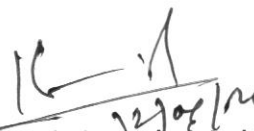
